REGULAR COUNCIL MEETING BOROUGH OF WOODBURY HEIGHTS 500 ELM AVENUE, WOODBURY HEIGHTS, NJ 08097 JANUARY 15, 2014 7:30 P.M.

Mayor Harry W. Elton, Jr. called the meeting to order with the following note: Adequate notice of this meeting has been provided by adopting a schedule of meetings for 2014 which was faxed to the South Jersey Times and Courier Post on January 6, 2014 and posted on the bulletin board in the Municipal Building conforming to the directives of the "Open Public Meetings Act".

Mayor Elton led everyone in the Pledge of Allegiance.

The call of roll showed the following to be present: Councilman William Packer, Councilwoman Cara Witasick, Councilman Harold "Hap" Pye, Councilman Duane Pheasant, Councilwoman Debra Truhan and Councilman Eshia "Jake" Jacob. Also in attendance were Borough Solicitor Barry Lozuke, Borough Engineer Mark Brunermer and Janet Pizzi, Borough Clerk/Administrator.

PUBLIC PORTION: Mayor Elton opened the public portion of the meeting for questions or comments:

Tom Butts, Gloucester County Emergency Director of Emergency and Andy Lovell, Gloucester County EMS Chief made a presentation regarding the possibility of providing Gloucester County EMS services in the Borough of Woodbury Heights. Packer asked if the cost is covered by insurance. Mr. Butts replied that the County bills the patient's insurance directly and if there is no insurance, there is no charge for County residents. Councilwoman Witasick asked if an increase in participating towns will require an increase in County personnel. Mr. Butts replied "yes". Councilman Pye asked about the Borough's truck. Mr. Butts replied that if an ambulance can get inspected and is of value to the County, the County will lease it from the Borough. Councilwoman Truhan asked about the cost to taxpayers and was informed that it is included in the broad based County Tax. Councilwoman Truhan asked where the stations are located and was advised that they are within five minutes of Woodbury Heights. Discussion ensued with various residents and members of the Woodbury Heights Fire Department/EMS voicing concerns and opposition to County EMS services. Woodbury Heights Fire Chief Robbie Conley stated several reasons why the Borough will lose money doing this such as with the state training fund, first aid equipment, etc., and noted that this this not the time to make this move. Former Fire Chief Ed Hernisey stated that the Woodbury Heights ambulance doesn't respond quick enough and that most of the time it's actually Deptford that is responding.

Councilman Pye stated that Council is the voice of the people and asked to move Resolution 35-2014:
