A motion to approve the minutes of the Regular Council Meeting 10-20-2010 was made by Councilman Scull and seconded by Councilwoman Truhan. A roll call vote in favor was unanimous.

For the month of October 2010, the Borough Clerk reported total receipts in the amount of \$266.93. Of this amount, \$265.93 was turned over to the Treasurer and \$1.00 was deposited into the Dog Fund.

### **COMMITTEE REPORTS**

Finance and Administration: Councilman Scull reported that the tax collection rate as of November 23, 2010 is 96.047%. Councilman Scull will be reviewing the tax sale list prior to it going out.

Mayor Elton reported on behalf of Councilwoman Degnen that this year's JIF dividend is \$7227.00. An Elected Officials Seminar will be held on November 30, 2010 at 5:30 p.m. at Nicolosi's. The Heights Highlights deadline for submission is December 04, 2010.

#### COMMITTEE REPORTS CONTINUED

Water & Sewer: Councilwoman Truhan reported that the Water & Report will be on file in the Clerk's office. Due to the continuous in house and formal training, the Public Works employees are able to diagnose and complete the necessary repairs to the pumps at the Borough sewer stations. Discussion ensued regarding the savings on infiltration which has far exceeded what was anticipated also due to the in house work by Public Works.

Recreation & Civic: Councilman Jacob reported that 417 people showed up for flu shots at the Woodbury Heights Elementary School. The Veteran's Memorial Service was very successful with 250 people in attendance. A Mayoral Proclamation was presented to Angelo Romeo, Gloucester County Veterans' Affairs Director who will retire at the end of this year. Councilman Jacob thanked Infant Jesus Parish, New Beginnings Church, Congressman Andrews, Wilma Belcher for her volunteer work and all of those in attendance.

A motion to request the Solicitor to prepare a Resolution to add Veteran's Way to West Jersey Avenue in Woodbury Heights was made by Councilman Jacob and seconded by Councilman Scull. A roll call vote in favor was unanimous.

BILL LIST: A motion to approve the bill list as presented this evening was made by Councilwoman Truhan and seconded by Councilman Jacob. A roll call vote in favor was unanimous. The bill list was approved.

PUBLIC PORTION: Mayor Elton opened the public portion of the meeting for questions or comments.

Wilma Belcher, Lake Avenue: Mrs. Belcher advised Mayor and Council that the picture in the Gloucester County Times of our Veterans Day Ceremony was labeled "Woodbury" not "Woodbury Heights". She contacted the Gloucester County Times for a correction.

Upon hearing no additional questions or comments, Mayor Elton closed the public portion of the meeting.

Mayor Elton informed the public that the Governing Body will now go into closed session and as soon as it is ended, they will return to open session to adjourn. Immediately following, Mayor and Council will hold a Board of Health Special Meeting to consider a Resolution to appoint Jolyn Gregoria as Deputy Registrar of Vital Statistics. Members of the public are welcome to return to the open session and to the Board of Health Special Meeting.

The Mayor and Council went into closed session at 8:00 p.m. and returned to open session at 8:10 p.m.

A motion to adjourn was made by Councilman Scull and seconded by Councilwoman Truhan. All of Council agreed. The meeting adjourned at 8:10 p.m.
