Reorganization Minutes January 4, 2016

Mayor Conley called the meeting to order at 7:00 pm and announced that the meeting confirms to the directives of the open public meetings act of New Jersey. He then asked all to rise and pledge allegiance to the flag.

Mayor Conley called on Mr. Borelli to administer the Oaths of Office for Councilman Harold "Hap" Pye, Class III, term ending 12/31/16, Victoria Holmstrom, Class II, term ending 12/31/16, Joseph Martino, Class IV term ending 12/31/19, Stephen Hart, Class IV, term ending 12/31/19 and Erin Frombach, Alternate Member 1, term ending 12/31/17. Mrs. Frombach and Mr. Hart were not present, and therefore were not sworn in.

Mr. Hart arrived at 7:02, and his Oath of Office was administered by Mr. Borelli at that time.

Roll call found the following members present: Mr. Farrell, Mr. Martino, Mr. Flynn, Mayor Conley, Mr. Deeck, Mr. Hart, Mrs. Sesko, Councilman Pye, Mrs. Holmstrom and Mr. Elton. Absent were the following: Mrs. Frombach.

Mayor Conley asked for nominations for Chairman. A nomination was made and seconded, for Mr. Elton. Harry W. Elton Jr., was elected by the following roll call vote; Mr. Farrell, yes, Mr. Martino, yes, Mr. Flynn, yes, Mayor Conley, yes, Mr. Deeck, yes, Mr. Hart, yes, Mrs. Sesko, yes, Councilman Pye, yes, Mrs. Holmstrom, yes and Mr. Elton abstained.

Mayor Conley then turned the meeting over to Chairman Elton who asked for nominations for Vice Chairman. A nomination was made by Mr. Flynn and seconded by Mr. Hart for Bruce Farrell. Mr. Farrell was elected Vice Chairman by the following roll call vote; Mr. Martino, yes, Mr. Flynn, yes, Mayor Conley, yes, Mr. Deeck, yes, Mr. Hart, yes, Mrs. Sesko, yes, Councilman Pye, yes, Mrs. Holmstrom, yes, Chairman Elton, yes, and Mr. Farrell abstained.
