

**ORDINANCE 11-2016**

**AN ORDINANCE OF THE BOROUGH OF WOODBURY HEIGHTS,  
COUNTY OF GLOUCESTER, STATE OF NEW JERSEY  
REPEALING AND AMENDING CHAPTER 63 OF THE BOROUGH OF  
WOODBURY HEIGHTS CODE  
ENTITLED "HANDICAPPED PARKING"**

**WHEREAS**, the Borough of Woodbury Heights strives to adopt and implement general regulations that advance the goals and objectives of the Borough in a clear and consistent fashion; and

**WHEREAS**, the Mayor and Borough Council of the Borough of Woodbury Heights have determined that certain amendments to Chapter 63 entitled "Handicapped Parking" are necessary and warranted under New Jersey law.

**NOW, THEREFORE, BE IT ORDAINED**, by the Mayor and Borough Council of the Borough of the Woodbury Heights, in the County of Gloucester and State of New Jersey that Chapter 63 of the Borough Code entitled "Handicapped Parking" is hereby repealed, in its entirety; and

**BE IT FURTHER ORDAINED**, that Chapter 63 entitled "Handicapped Parking" is hereby amended and supplemented, as follows:

**Section I: Purpose** The purpose of this ordinance is to amend Chapter 63 of the Borough Code entitled "Handicapped Parking".

**Section II: Adoption.**

**§63-1.** The purpose of this Article is to establish certain private and public property areas that are open to the public or in to which the public is invited, that shall prohibit parking in areas designated as handicapped parking spaces for use by persons who have been issued special identification cards by the Division of Motor Vehicles. No other person shall be permitted to park in these designated spaces.

**§63-2. Statutory Authority.** This article is enacted in accordance with N.J.S.A. 40:18-2.46 and N.J.S.A. 39:4-197, respectively, which does confer upon the Borough of Woodbury Heights the right to establish and regulate handicapped parking spaces in order to preserve and safeguard the public health, safety and welfare.

**§63-3. Spaces Designated.** Any public or private property area containing a designation of a handicapped parking space shall be used solely by persons who have been issued special identification cards by the Division of Motor Vehicles. No other person shall be permitted to park in these spaces, which spaces shall be so marked by signs indicating handicapped parking spaces.

**§63-4. Definitions.** In applying and interpreting this chapter, the following definitions shall be used.

Designation of Handicapped Parking Spaces – Spaces identified with a clearly visible sign displaying the international symbol of the handicapped or with the words "Handicapped Parking Only", or both, together with a designation of the penalty for violation.

Special License Plates, Cards and Other Insignia – License plates and special vehicle identification cards issued by the director of the Division of Motor Vehicles pursuant to N.J.S.A. 39:4-205 and 39:4-206.

**§63-5. Violations and Penalties** For a violation of any provision of this Article, the penalty shall be a fine of \$250.00 for the first offense and, for subsequent offenses, a fine of at least \$250.00 and up to 90 days community service on such terms and in such form as the Court shall deem appropriate, or any combination thereof.

**§63-6. Enforcement** The terms and provisions of this chapter shall be enforced by the Borough of Woodbury Heights Police Department.

**SECTION III: Effective Date.**

This Ordinance shall take effect upon final adoption, publications and as otherwise provided by law.

**SECTION IV: Repealer.**


All Ordinances or parts of Ordinances inconsistent with the terms of this Ordinance be and are hereby repealed to the extent of such inconsistency.

All Ordinances or parts of Ordinances not inconsistent with the terms and provisions of this Ordinance are hereby saved from repeal.





**CERTIFICATION**


