ORDINANCE NO. 11 - 2016

ORDINANCE OF THE BOROUGH OF WOODBURY HEIGHTS, COUNTY OF GLOUCESTER, NEW JERSEY CANCELING CERTAIN FUNDED APPROPRIATION BALANCES HERETOFORE PROVIDED FOR WATER AND SEWER UTILITY CAPITAL IMPROVEMENTS AND REAPPROPRIATING SUCH FUNDED APPROPRIATION BALANCES FOR OTHER WATER AND SEWER UTILITY CAPITAL PROJECTS

BACKGROUND

WHEREAS, the Borough of Woodbury Heights, County of Gloucester, New Jersey ("Borough"), duly and finally adopted Bond Ordinances 8-2006, 6-2007(b), 4-2009, and 14-2012; and

WHEREAS, the Borough, having completed the projects authorized under the Bond Ordinances, has remaining balances in total of \$75,107.94;

WHEREAS, the Borough is desirous of canceling and reappropriating certain funded balances for the acquisition of various pieces of water and sewer capital equipment for the Borough.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF WOODBURY HEIGHTS, COUNTY OF GLOUCESTER, NEW JERSEY (NOT LESS THAN TWO-THIRDS OF ALL THE MEMBERS THEREOF AFFIRMATIVELY CONCURRING), PURSUANT TO THE PROVISIONS OF THE LOCAL BOND LAW, CHAPTER 169 OF THE LAWS OF 1960 OF THE STATE OF NEW JERSEY, AS AMENDED AND SUPPLEMENTED ("LOCAL BOND LAW"), AS FOLLOWS:

Section 1. The following appropriations remaining as a balance in the following Bond Ordinance heretofore adopted by the Borough are hereby cancelled:

Section 2. The sum of \$53,107.94, which represents the funded appropriations cancelled in Section 1 hereof, is hereby reappropriated from the Bond Ordinances 8-2006, 6-2007(b), 4-2009, and 14-2012 for the Purchase of Water and Sewer Department Vehicles.

Section 3. The sum of \$22,000.00 which represents the unfunded appropriation cancelled in Section 1 hereof, is hereby cancelled from Bond Ordinance 4-2009,

Section 4. The period of usefulness of the Improvements, within the limitations of the Local Bond Law and according to the reasonable life thereof, is not less than five (5) years.

Section 5. The Capital Budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended Capital Budget and Capital Program as approved by the Director of the Division of Local Government Services, is on file with the Borough Clerk and available for inspection.

Section 6. The Improvements authorized hereby are not current expenses and are general improvements that the Borough may lawfully make. No part of the cost of the Improvements authorized hereby has been or shall be specially assessed on any property specially benefited thereby.

Section 7. All ordinances, or parts of ordinances, inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 8. This ordinance shall take effect twenty (20) days after the first publication thereof after final passage.
