

ORDINANCE 2-2016

**AN ORDINANCE AMENDING ORDINANCE 12-2011 AND ORDINANCE 12-2015 CODIFIED
WITHIN SECTION 64B OF THE BOROUGH OF WOODBURY HEIGHTS CODE
CONCERNING THE REGISTRATION, INSPECTION AND LICENSING OF RESIDENTIAL
RENTAL PROPERTIES**

WHEREAS, Ordinance 12-2011 and Ordinance 12-2015 established policies and procedures for the registration, inspection and licensing of residential rental properties within the Borough of Woodbury Heights; and

WHEREAS, these policies are codified at Section 64B-1, et seq. of the Woodbury Heights Code; and

WHEREAS, a discrepancy exists within Section 64B-2 that requires an amendment and clarification to the existing Ordinance;

NOW, THEREFORE, BE IT ORDAINED, by the Borough Council of the Borough of the Woodbury Heights with the Mayor concurring, as follows:

SECTION I:

Section 64B-2 entitled "Registration Required" is hereby amended, in relevant part, to read as follows:

All rental units consisting of three (3) or more units of dwelling space shall hereafter be registered with the Clerk or designee of the Borough of Woodbury Heights or such other person as designated by the Borough Council, on forms which shall be provided for that purpose and which shall be obtained from the Clerk or designee. *It shall be required that such registration take place on an annual basis every year as provided herein.*

SECTION II: Any and all other Ordinances or part of Ordinances incontinent with the terms of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION III: Saved From Repeal.


Any and all other Ordinances or parts of Ordinances not inconsistent with the terms and provisions of this Ordinance are hereby saved from repeal.


