ORDINANCE NO. 3 -2012**

**AN ORDINANCE APPROPRIATING THE SUM OF \$20,000.00 TO BE USED FOR IMPROVEMENTS TO  
BOROUGH HALL WITHIN THE BOROUGH OF WOODBURY HEIGHTS, COUNTY OF  
GLOUCESTER, STATE OF NEW JERSEY**

WHEREAS, the Governing Body desires to authorize improvements to Borough Hall within the Borough of Woodbury Heights; and

WHEREAS, sufficient funds are available for said purpose from the Borough's Capital Improvement Fund;

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Borough Council of the Borough of Woodbury Heights, County of Gloucester and State of New Jersey, that:

SECTION 1: There is hereby appropriated from the following sources the sum of \$20,000.00 to be used for the following capital project within the Borough of Woodbury Heights:

<u>Purpose/Improvement</u>	<u>Estimated Total Cost</u>	<u>Capital Improvement Fund</u>	<u>Period of Usefulness</u>
A. Improvements to Borough Hall	\$20,000	\$20,000	5 years


SECTION 2: In connection with the amounts authorized in Section 1, the Borough makes the following determinations:

- a) The purpose described in Section 1 is not a Current Expense and is an improvement, which the Borough may lawfully make as a general improvement.
- b) The period of usefulness of the purpose described in Section 1 hereof is within the limitations of the Local Bond Law and according to the reasonable life thereof is five (5) years or more.
- c) No debt is authorized by this ordinance.
- d) The capital budget of the Borough is hereby amended.

SECTION 3: All ordinances or parts of ordinances that are inconsistent with the terms of this ordinance be and the same are hereby repealed to the extent of their inconsistency.

SECTION 4: This ordinance shall take effect immediately upon proper passage, publication in accordance with law and after final adoption as provided by law.


