ORDINANCE 5-2015**

**AN ORDINANCE APPROPRIATING THE SUM OF \$90,500
TO BE USED FOR ACQUISITION OF PICKUP TRUCK FOR
THE FIRE DEPARTMENT AND RECONSTRUCTION OF
OAK AVENUE AND FOURTH STREET IN
THE BOROUGH OF WOODBURY HEIGHTS,
COUNTY OF GLOUCESTER, STATE OF NEW JERSEY**

WHEREAS, the Governing Body desires to purchase a pickup truck for use by the Fire Department of the Borough of Woodbury Heights; and

WHEREAS, sufficient funds are available for said purpose through a donation; Community Development Block Grant Funding and funds from the Borough's Capital Improvement Fund;

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Borough Council of the Borough of Woodbury Heights, County of Gloucester and State of New Jersey, that:

SECTION 1: There is hereby appropriated from the following sources the sum of \$31,500 to be used for the following capital project within the Borough of Woodbury Heights:

<u>Purpose/Improvement</u>	<u>Estimated Total Cost</u>	<u>Capital Improvement Fund</u>	<u>Grants/ Other Funds</u>	<u>Period of Usefulness</u>
A Acquisition of pickup truck for fire department	\$31,500	\$4,500	\$27,000	5 years
B Oak Avenue and Fourth Street Reconstruction	\$59,000	\$10,562	\$48,438	10 years


SECTION 2: In connection with the amounts authorized in Section 1, the Borough makes the following determinations:

- a) The purpose described in Section 1 is not a Current Expense and is an improvement, which the Borough may lawfully make as a general improvement.
- b) The period of usefulness of the purpose described in Section 1 hereof is within the limitations of the Local Bond Law and according to the reasonable life thereof is five (5) years or more.
- c) No debt is authorized by this ordinance.
- d) The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services, is on file with the Borough Clerk and available for inspection.



SECTION 4: This ordinance shall take effect immediately upon proper passage, publication in accordance with law and after final adoption as provided by law.
