ORDINANCE AMENDING ORDINANCE 1-2012 ENTITLED "ORDINANCE ESTABLISHING SALARIES AND COMPENSATION OF VARIOUS BOROUGH OFFICERS AND EMPLOYEES OF THE BOROUGH OF WOODBURY HEIGHTS FOR THE CALENDAR YEAR 2012"

BE IT ORDAINED by the Borough Council of the Borough of Woodbury Heights, with the Mayor concurring as follows:


A. Ordinance 1 – 2012 entitled " Ordinance Establishing Salaries and Compensation of Various Borough Officers and Employees of the Borough of Woodbury Heights for the calendar year of 2012" is hereby amended, in part, to reflect the below listed revisions to the 2012 compensation plans for the enumerated employment positions as follows:

Patrolman 7 Years	\$76,167.80 per annum
Patrolman 1	\$75,421.06 per annum
Patrolman 2	\$66,003.72 per annum
Patrolman 3	\$46,850.91 per annum
Patrolman 4	\$40,667.16 per annum
Probationary	\$38,500.00 per annum
Police Chief	\$99,821.28 per annum


