Debra Truhan as a Class III Member for a term expiring December 31, 2013;


Victoria Holmstrom as a Class II Member for a term expiring December 31, 2013;

Joseph Smith as an Alt 1 Member for a term expiring December 31, 2014;


Joseph Martino as an Alt 3 Member for a term expiring December 31, 2014;

Debra Sesko as an Alt 4 Member for a term expiring December 31, 2014


