

RESOLUTION 40 – 2016
RESOLUTION APPOINTING PRINCIPAL LICENSED OPERATOR AND BACKUP LICENSED
PUBLIC WATER AND SEWER OPERATOR

WHEREAS, the recent retirement of the Borough's Public Works Manager required the Borough to promptly employ the services of Donna Domico as the backup licensed Public Water and Sewer Operator memorialized by Resolution 29-2016; and

WHEREAS, the appointment of such Operator was intended as an interim, temporary appointment on an annual basis; and

WHEREAS, the Borough now desires to appoint Donna Domico as the acting Licensed Principal Public Works Manager and Operator; and

WHEREAS, in connection with such appointment the Borough desires to appoint Martin Finger as the backup licensed Public Water and Sewer Operator in compliance with all applicable law, rules and regulations; and

WHEREAS, both Donna Domico, as well as Martin Finger, possess all of the qualifications and licenses necessary to serve in such positions and have the required experience to operate the public water and sewer systems and facilities of the Borough; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1,) et. seq. requires that a Resolution authorizing the award of a contract for "Professional Services" without competitive bids must be publicly advertised;

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Woodbury Heights, with the Mayor concurring, that Donna Domico is hereby appointed as the principal licensed operator of the Borough's Public Water and Sewer facilities at an annualized salary of Fifteen Thousand (\$15,000.00) Dollars;


BE IT FURTHER RESOLVED by the Borough Council of the Borough of Woodbury Heights, with the Mayor concurring, that Martin Finger is hereby appointed as the backup licensed operator of the Borough's Public Water and Sewer facilities at an annualized salary of Five Thousand (\$5,000.00) Dollars,

BE IT FURTHER RESOLVED that these appointments are awarded without competitive bidding as a "Professional Service" under the provisions of the Local Public Contracts Law because said appointments encompass professional services recognized, licensed and regulated by law;

BE IT FURTHER RESOLVED that a notice of these appointments shall be published, one time, within ten (10) days of the adoption hereof,

BE IT FURTHER RESOLVED that a certified copy of this Resolution be forwarded to the applicable Department of the State of New Jersey forthwith after the adoption hereof.
