**RESOLUTION OF DETERMINATION BY THE GOVERNING BODY OF THE
BOROUGH OF WOODBURY HEIGHTS OF AMOUNT TO BE RAISED BY TAXATION FOR
THE GATEWAY REGIONAL HIGH SCHOOL BOARD OF EDUCATION FOR THE SCHOOL
YEAR 2010/2011**

WHEREAS, the GATEWAY REGIONAL HIGH SCHOOL BOARD of Education presented to the voters, at the annual School Election held on Tuesday, April 20, 2010, questions concerning the tax levy requirements for the Board of Education for General Fund; and

WHEREAS, the voters at said election, having rejected the General Fund questions; and

WHEREAS, the Board of Education transmitted the Budget to the Borough Councils of the Boroughs of National Park, Wenonah, Westville, and Woodbury Heights on Thursday, April 22, 2010 pursuant to N.J.S.A. 18A: 22-37; and

WHEREAS, the Borough Council of the Borough of Woodbury Heights thoroughly reviewed the Budget and related information as presented by the Board of Education; and

WHEREAS, the Borough Council of the Borough of Woodbury Heights consulted with the Board of Education and the other Gateway Group sending district Boroughs through their designated representatives; and

WHEREAS, after careful deliberation of the information relative to the School Board Budget all Borough Councils are in agreement;

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Woodbury Heights, County of Gloucester, State of New Jersey, that the local district's tax levy requirements for the GATEWAY REGIONAL HIGH SCHOOL BOARD of Education General Fund be \$2,687,263.46. This reduced General Fund tax levy will allow the district to remain above the adequacy level determined in accordance with the "School Funding Reform Act".


BE IT FURTHER RESOLVED, that Exhibit "A" attached hereto, and hereby incorporated herein by reference, represents the reductions in General Fund Line Items for the District, which reductions as applied to the General Fund shall be prorated therein among the sending Districts thereby reducing the amount to be raised by taxation in the Borough by the sum of \$24,528.46.

BE IT FURTHER RESOLVED by the Borough of Woodbury Heights that the Municipal Clerk is directed to certify by May 19, 2010 to the Gloucester County Board of Taxation, the Gloucester County Superintendent of Schools, the Woodbury Heights Borough Tax Assessor, the Division of Local Finance of the Department of the Treasury, State of New Jersey, the Municipal Clerk of the Borough of Woodbury Heights and the GATEWAY REGIONAL HIGH SCHOOL BOARD of Education, that the amount of \$2,687,263.46 is necessary to be raised by taxation for 2010-2011 regional school year in said Borough of Woodbury Heights for the General Fund Revenue exclusive of current debt service levy, which amount shall be included in taxes to be raised, levied and collected in said municipality for General Fund of the School, and


BE IT FURTHER RESOLVED, that the Municipal Clerk forward copies of this resolution to the persons and or departments herein named for certification purposes.


