

RESOLUTION 68-2010

RESOLUTION APPROVING THE EXTENSION OF AN INTERLOCAL SERVICES AGREEMENT AS AMENDED AND NOW KNOWN AS A SHARED SERVICE AGREEMENT BETWEEN BOROUGH OF WOODBURY HEIGHTS AND THE COUNTY OF GLOUCESTER FOR THE PARTICIPATION IN THE CDBG GRANT PROGRAM AND HOME INVESTMENT PARTNERSHIP PROGRAMS FOR FISCAL YEARS 2011-2013, INCLUSIVE

WHEREAS, Title I of the Housing and Community Development Act of 1974, as amended, commonly known as the Community Development Block Grant Program (hereafter, "CDBG Program") provides federal funds to certain urban counties for the use therein; and

WHEREAS, the Cranston-Gonzales National Housing Act of 1991, as amended, provides federal funds to certain counties through its HOME Investment Partnership Program (hereafter "HOME Program"); and

WHEREAS, the above Acts established certain criteria that need to be satisfied, including contractual commitments from participation municipalities, for an urban county to receive the aforesaid federal funding; and

WHEREAS, the Shared Services Statute, N.J.S.A. 40A:65-1 et seq., provides a mechanism through which counties and municipalities may enter into an agreement for the provision of services, including use of federal funds in accordance with federal programs; and

WHEREAS, the Borough of Woodbury Heights and the County of Gloucester have previously entered into an Agreement entitled "Interlocal Services Agreement Between the County of Gloucester and Certain Community Development Activities", heretofore shall be known as Shared Service Agreement, for the three (3) consecutive fiscal years (2005-2007), which Agreement was subsequently extended by Resolution for three (3) additional, consecutive fiscal year periods, encompassing the periods from 1999-2001, 2001-2004, and 2005-2007, and 2008-2010 inclusive; and

WHEREAS, it is now necessary to extend the aforesaid Agreement in order to meet Federal and State requirements for receipt and use of funds under the CDBG and HOME Programs.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Woodbury Heights, County of Gloucester, as follows:


1. The governing body hereby affirms, ratifies, and extends the Interlocal Services Agreement, now known as the Shared Service Agreement as amended between the County of Gloucester and the Borough of Woodbury Heights for three (3) additional, consecutive fiscal years (2011 through 2013).
2. This resolution shall take effect immediately upon passage.


