

**RESOLUTION 92 - 2010
RESOLUTION AUTHORIZING
ACCEPTANCE OF A HIGHWAY SAFETY GRANT
ADMINISTERED BY THE NEW JERSEY
DIVISION OF HIGHWAY TRAFFIC SAFETY**

WHEREAS, the Police Department has heretofore applied for and received approval of a grant in the sum of \$4,400.00 to fund overtime enforcement of impaired driving in a program entitled "Over the Limit Under Arrest 2010 Statewide Crackdown"; and

WHEREAS, the funding approved will defray overtime pay to officers at a rate not to exceed \$50.00 per hour; and


WHEREAS, the Borough intends approval of this grant with the specific condition that control officers participate on a voluntary basis only and shall agree to waiver of any collective bargaining provision requiring overtime pay in excess of \$50.00 per hour;

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Woodbury Heights, with the Mayor concurring, that the Police Department is hereby authorized to accept and participate in a project grant for overtime enforcement of impaired driving laws, such project administered by the New Jersey Division of Highway Traffic Safety on the condition that any patrol officers participating must do so on a voluntary basis and after waiver of any collective bargaining rates of overtime pay obligations above \$50.00 per hour;






