

ORDINANCE 13 - 2011
AN ORDINANCE AMENDING RATES OF PAYMENT
FOR OFF-DUTY POLICE SERVICES
AND RELATED FEES

WHEREAS, Section 27-16(C) and (D) provides for fees related to off-duty police services and the provision of a police vehicle in connection therewith; and


WHEREAS, the aforesaid fees were last established in 2007 by Ordinance No. 9 - 2007 and require revisions to meet the increased costs relating to such services;

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Woodbury Heights, that Section 27-16 (C) of the Woodbury Heights Code is amended to reflect the sum of \$72.15 per hour for police officer services and Subsection (D) of Section 27 - 16 is amended to provide a fee of \$19.50 per hour for use of a police vehicle.

BE IT FURTHER ORDAINED as follows:

1. All Ordinances inconsistent with the provisions of this Ordinance be and are hereby repealed to the extent of such inconsistency;
2. All Ordinances of the Borough not inconsistent with the provision of this Ordinance be and are hereby saved from repeal;
3. This Ordinance shall take effect immediately upon approval and publication and as otherwise provided by law;
4. Each section, subsection, sentence, clause or phrase of this Ordinance is declared to be an independent section, subsection, sentence, clause and phrase and the finding or holding of any such portion of this Ordinance to be unconstitutional, void, unlawful or ineffective for any cause or reason shall not affect any other portion of this Ordinance.



SUMMARY STATEMENT


