

ORDINANCE 5-2011
ORDINANCE REPEALING SECTION 22-1
OF THE WOODBURY HEIGHTS CODE ENTITLED
"OPEN PUBLIC RECORDS, ACCESS"

WHEREAS, amendments to N.J.S.A. 47:1A-5(b) and the Superior Court, Appellate Division's decision in Smith v. Hudson County Register, 411 N.J. Super. 538 (App. Div. 2010) have modified the administrative process and the fees associated with requests for government records; and

WHEREAS, provisions of Section 22-1 of the Woodbury Heights Code no longer comply with current law; and

WHEREAS, consistent with the new legislation the Borough hereby intends to repeal Section 22-1 and to adopt an Open Public Records Act Request Form which is consistent with current law;


NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Woodbury Heights, that Section 22-1 of the Woodbury Heights Code entitled "Open Public Records Access" is hereby repealed in its entirety;

BE IT FURTHER ORDAINED that the "Open Public Records Act Request Form" attached hereto is hereby adopted as the form to be utilized by the custodian of records in connection with requests for government records pursuant to N.J.S.A. 47:1A-5(b), et seq;

BE IT FURTHER ORDAINED that the clerk or other custodian of records under existing law shall respond to all requests for government records in a form and manner consistent with N.J.S.A. 47:1A-5(b), et seq and consistent with all other applicable law and the common law;

BE IT FURTHER ORDAINED that this Ordinance shall take effect upon its adoption, publication and as otherwise provided by law.


