WHEREAS, Olde Towne Quality was the lowest quote received for said project in the amount of \$23,720.00; and


WHEREAS, funds are available for the award of the contract as certified by the Borough CFO; and

WHEREAS, Olde Towne Quality has filed the requisite disclosures required by N.J.S.A. 19:44a-20.8.






CERTIFICATION OF AVAILABILITY OF FUNDS


