**WHEREAS**, the Borough of Woodbury Heights desires to purchase two trucks for public works operations; and


**WHEREAS**, these vehicles are available for purchase under State Contract #A88759 from Hertrich Fleet Services, Inc.; and




**CERTIFICATION OF AVAILABILITY OF FUNDS**


