

**RESOLUTION 35- 2017**  
**RESOLUTION AWARDDING CONTRACT FOR**  
**THE RECONSTRUCTION OF WEST JERSEY AVENUE PROJECT**

**WHEREAS**, the Borough publicly invited Bids for all work and material associated with the reconstruction of West Jersey Avenue Project pursuant to an “Open and Fair” process; and

**WHEREAS**, a total of ten (10) proposals were received and publicly opened by the Borough Clerk on February 10, 2017 from the following bidders: Arawak Paving company, Inc; South State, Inc.; Gerald A. Barrett, LLC; Ricky Slade Construction, Inc.; American Asphalt Company, Inc.; Landberg Construction, LLC; A Team Concrete, Inc.; Jersey Construction, Inc.; Charles Marandino, LLC; Pioneer Pipe Contractor’s Inc.; and

**WHEREAS**, the Borough Engineer has reviewed the bid packages received by the Borough and has further determined that the qualified low bidder for the project is Arawak Paving Company, Inc, which was confirmed by the Borough Solicitor; and

**WHEREAS**, the Base Bid Proposal received from Arawak Paving Company, Inc. reflected the sum of \$133,300.00, along with Alternate 1 Bid in the amount of \$2,800.00 and Alternate 2 Bid in the amount of \$2,800.00 for a total bid amount of \$138,900.00; and


**WHEREAS**, the engineer has recommended the award of a contract for the Base Bid, including the Alternate 1 Bid and Alternate 2 Bid to the aforesaid Arawak Paving Company, Inc. and the Solicitor has reviewed the Bid Proposal and Surety submitted by the contractor and has also recommended an award of contract; and

**WHEREAS**, funds are available to defray the costs of the project as proposed, as certified by the Borough CFO;

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Woodbury Heights, County of Gloucester, State of New Jersey that a contract for the reconstruction of West Jersey Avenue Project is hereby awarded to Arawak Paving Company, Inc. for the Base Bid and Alternate 1 and Alternate2 proposals in the sum of \$138,900.00; and

**BE IT FURTHER RESOLVED** that the Mayor and Clerk are hereby authorized and directed to execute a contract for same and the Clerk is hereby authorized and directed to return all Bid Surety to the unsuccessful bidders.


