

ORDINANCE 8 - 2017

ORDINANCE AMENDING THE 2017 SALARY ORDINANCE (ORDINANCE 1-2017) OF VARIOUS BOROUGH OFFICERS AND EMPLOYEES OF THE BOROUGH OF WOODBURY HEIGHTS

WHEREAS, the Mayor and Borough Council heretofore adopted the 2017 Salary Ordinance memorialized by the adoption of Ordinance 1-2017; and

WHEREAS, the Mayor and Borough Council desire to amend and supplement the 2017 Salary Ordinance.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Woodbury Heights, with the Mayor concurring, as follows:

1. The position entitled "Special Officer: Academy Cadet" is hereby repealed and rescinded, effective immediately;
2. The Salary Ordinance shall further be amended and supplemented to include the hourly wage position of "Special Law Enforcement Officer (Hired after October 1, 2017)", which position shall have a salary range of \$9.00 to \$15.00 per hour.
3. This Ordinance shall take effect after final passage and publication as required by law; and
4. All Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance be and are hereby repealed.


