

**ORDINANCE 9-2017**

**AN ORDINANCE AMENDING CHAPTER 104, SECTION 30, SCHEDULE I: NO  
PARKING OF THE CODE OF THE BOROUGH OF WOODBURY HEIGHTS  
(NO PARKING)**

**BE IT ORDAINED**, by the Mayor and Council of the Borough of Woodbury Heights, County of Gloucester and State of New Jersey as follows:

**Section 1.** Chapter 104, Section 30, Schedule I: No parking is hereby amended by adding the following **No Parking** street location:

<b>Name of Street</b>	<b>Side</b>	<b>Location</b>
Barlow Avenue	East	from Elm Avenue to Maple Avenue
Barlow Avenue	West	from Elm Avenue to Maple Avenue

**Section 2.** Chapter 104, Section 30, Schedule J: Drive-Thru Lane is created at the following street location:

<b>Name of Street</b>	<b>Side</b>	<b>Location</b>
Barlow Avenue	East	from Elm Avenue 115' north along Block 70, Lot 1.04

**Section 3. Repealer**


All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.




