


ORDINANCE 1-2018

**ORDINANCE ESTABLISHING SALARIES AND
COMPENSATION OF VARIOUS BOROUGH OFFICERS
AND EMPLOYEES OF THE BOROUGH OF WOODBURY
HEIGHTS FOR THE CALENDAR YEAR 2018**

BE IT ORDAINED by the Borough Council of the Borough of Woodbury Heights, with the Mayor concurring, as follows:

1. Annual salaries and compensation for various Borough Officers and Employees for the calendar year 2018 are established as set forth on the list attached hereto with such salaries and compensation payable bi-weekly unless otherwise specified;
2. This Ordinance shall be effective retroactive to January 1, 2018, after final passage and publication as required by law; and
3. All Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance be and are hereby repealed.
