ORDINANCE 2-2018**

**AN ORDINANCE APPROPRIATING THE SUM OF \$50,000
TO BE USED FOR THE RECONSTRUCTION AND/OR REPAVING OF
CENTRAL AVENUE FROM SECOND STREET TO ALLIANCE AVENUE IN
THE BOROUGH OF WOODBURY HEIGHTS,
COUNTY OF GLOUCESTER, STATE OF NEW JERSEY**

WHEREAS, the Borough Council of the Borough of Woodbury Heights desires to make improvements consisting of paving and/or curbing for pedestrian safety and ADA sidewalk improvements at the 100 and 200 Blocks of Central Avenue from Second Street to Alliance Avenue; and

WHEREAS, sufficient funds are available for said purpose through Community Development Block Grant Funding.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Borough Council of the Borough of Woodbury Heights, County of Gloucester and State of New Jersey, as follows:

SECTION 1: There is hereby appropriated from the following sources the sum of \$50,000 to be used for the following capital project within the Borough of Woodbury Heights:

A. Reconstruction and/or Repaving along Central Avenue from Second Street to Alliance Avenue, together with the acquisition of all materials and equipment and completion of all work necessary therefor and related thereto.	\$50,000		\$50,000	10 years

SECTION 2: In connection with the amounts authorized in Section 1, the Borough makes the following determinations:


- a) The purpose described in Section 1 is not a Current Expense and is an improvement, which the Borough may lawfully make as a general improvement.
- b) The period of usefulness of the purpose described in Section 1 hereof is within the limitations of the Local Bond Law and according to the reasonable life thereof is at least five (5) years or more.
- c) No debt is authorized by this Ordinance.
- d) The capital budget is hereby amended to conform with the provisions of this Ordinance to the extent of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services, is on file with the Borough Clerk and available for inspection.

SECTION 3: All Ordinances or parts of Ordinances that are inconsistent with the terms of this Ordinance be and the same are hereby repealed to the extent of their inconsistency.

SECTION 4: This Ordinance shall take effect immediately after final passage and publication in accordance with New Jersey Law.


