

ORDINANCE 2-2019

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 51, ARTICLE II, SECTION 51-18, OF WOODBURY HEIGHTS CODE ENTITLED "DOGS AND OTHER ANIMALS" CONCERNING ANIMAL CRUELTY INVESTIGATIONS

BE IT ORDAINED by the Borough Council of the Borough of Woodbury Heights, that Chapter 51, Article II, of the Woodbury Heights Code entitled "DOGS AND OTHER ANIMALS" is hereby amended and supplemented by the inclusion of Section 55-18, which is to read as follows:

§ 55-18 Animal Cruelty Investigations.


Gloucester County Animal Control Officers (GCACO), or other designate, may investigate, and/or require compliance for violations pursuant to N.J.S.A. 4:22. In the event the GCACO, or designate sees or recognizes a potential criminal situation, or the need arises where a criminal investigation is warranted, the GCACO shall make contact/report to the Municipal Humane Law Enforcement Officer for further action. The GCACO may continue to contribute to the investigation as requested or required.

BE IT FURTHER ORDAINED as follows:

1. **Effective Date:** This Ordinance shall take effect March 24, 2019 and upon final adoption, publication and as otherwise provided by law.
2. **Repealer:** All Ordinances or parts of Ordinances inconsistent with the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.
3. **Saved from Repeal:** All Ordinances or parts of Ordinances not inconsistent with the terms and provisions of this Ordinance are hereby saved from repeal.


