ORDINANCE 1-2019 ENTITLED "ORDINANCE ESTABLISHING SALARIES AND

BE IT ORDAINED by the Borough Council of the Borough of Woodbury Heights that Ordinance 1-2019 entitled "Ordinance of the Borough of Woodbury Heights Establishing Salaries and Compensation of Various Township Officers and Employees of the Borough of Woodbury Heights for the Calendar Year 2019", be and is hereby amended to reflect the following revision and amendment:

<u>POSITION</u>	<u>HOURLY MINIMUM</u>	<u>HOURLY MAXIMUM</u>
Special Law Enforcement Officer: Class III	\$22.50	\$30.00

BE IT FURTHER ORDAINED that the compensation for the Special Law Enforcement Officer, Class III shall be \$28.00, retroactive to September 1, 2019; and

BE IT FURTHER ORDAINED that this Ordinance shall take effect after final passage and publication and as otherwise required by law and that all Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance be and are hereby repealed to the extent of such inconsistency.


NOTICE
