

RESOLUTION 63-2020

RESOLUTION OF THE BOROUGH OF WOODBURY HEIGHTS AWARDING CONTRACT FOR THE 2020 CENTRAL AVENUE ROADWAY IMPROVEMENTS PROJECT

WHEREAS, the Borough of Woodbury Heights heretofore advertised for the submission of bids relative to the 2020 Central Avenue Roadway Improvements Project for the Borough; and

WHEREAS, bids for this road project were advertised pursuant to Section 4 of P.L. 1971, c.198 (C), [N.J.S.A.40A:11-4] and publicly opened by the Township Engineer on June 5, 2020; and

WHEREAS, the Borough received six (6) bid proposals from Landberg Construction, LLC (\$453,714.90); Mathis Construction Co., Inc. (*\$613,203.25- *corrected amount); Charles Marandino, LLC (\$624,480.00); Perna Finnigan, Inc.(\$625,725.20); Mount Construction Co., Inc. (\$696,030.00); and GWP Enterprises, Inc. (\$707,746.05) on June 5, 2020; and


WHEREAS, The Township Engineer has reviewed the bid proposals and has recommended the award of the Contract to Landberg Construction, LLC for the 2020 Central Avenue Roadway Improvements Project as the lowest responsible bidder based on the following comprehensive proposal submitted by Landberg Construction, LLC: NJDOT Work- \$242,909.90; Potable Water- \$177,225.00; Sanitary Sewer- \$33,580.00; for a Total Project Amount: \$453,714.90; and

WHEREAS, the bid submitted by the aforesaid Landberg Construction, LLC is in substantial compliance with the bid instructions and specifications generated by the Borough; and

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Woodbury Heights, with the Mayor concurring, that the 2020 Central Avenue Roadway Improvements Project is hereby awarded to Landberg Construction, LLC in the following amounts which shall not be exceeded: NJDOT Work- \$242,909.90; Potable Water- \$177,225.00; Sanitary Sewer- \$33,580.00; for a Total Project Amount: \$453,714.90, subject to and conditioned upon the provisions of performance surety and further compliance with the bid documents and specifications by Landberg Construction, LLC including verification of funds by the Borough CFO.

BE IT FURTHER RESOLVED, that the Borough Administrator is hereby authorized and directed to return all bid surety to all unsuccessful bidders forthwith after the adoption hereof.
